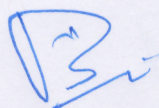

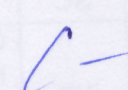

The above mentioned teachers shall join their duties at new place of posting as per latest guidelines i.e. if the distance is less than or up to 30 KM within 01 day more than 30 KM within 05 days from the date of issuance of this office order and submit the joining report to this office through their BEEOs failing which placement as HT shall be deemed as withdrawn automatically and the concerned teacher shall stand de-barred for one year or till next DPC whichever is later and the next eligible candidates in the panel will be considered for the placement of HT. Besides this no further extension for joining will be allowed in any circumstances. The above

orders are subject to the final outcome of SLP No: 8710 /2009 titled as RK Bharwal vs state of HP and CWP No:4070 /2009-II titled as Sham Lal Vs State of HP and LPA No:78/2014 titled as Rameshwari Vs State of HP .

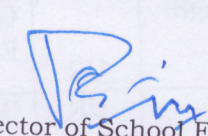
The Block Elementary Education Officers concerned Education Blocks are directed to relieve the concerned JBTs placed to the post of Head Teacher immediately. Before relieving the official to join at the new place of posting on placement, the BEEOs of concerned blocks may ensure that:

1. If any of the above incumbents are single teacher in their respective school, the BEEO concerned shall depute a teacher to the concerned GPS before relieving that incumbent.
2. There is no departmental inquiry / vigilance case pending against the incumbent.
3. The service particulars of concerned teachers be verified carefully, viz Name, Seniority No., Category (SC/ST/Gen/PwBD).
4. In case of change of present place of posting of the incumbent, the BEEO will relieve the incumbent after verifying the service particulars.
5. In case of any error/omission, if detected in these orders at a later stage, the same is liable to be corrected and such placement orders will be withdrawn and the incumbent shall have no claim for the placement.
7. The above placement is subject to review due to nay consequential/administrative reasons.
8. The incumbents will be entitled for TA/DA as admissible under the rules.
9. **The benefit of FR-22(1)(a)(1) is not applicable to incumbents in pursuance to the Directorate of Elementary Education, HP letter No. EDN-H(Ele)-IV-(6)-4-5/2020-Kangra-Misc dated 20 April, 2022.**
10. The concerned will send the relieving/joining report of the above concerned this office immediately.
11. The above placement is subject to review due to any consequential administrative reasons.
