**ORDER**

Whereas an Order dated 26.03.2021 (Annexure A) was issued to arrest the spread of COVID-19 in the State for compliance with order and guidelines issued by the Ministry of Home Affairs, Government of India for containment of COVID-19 dated 23.03.2021.

And whereas, after a careful review of the recent spike in COVID-19 cases it is evident that it still remains a public health risk and caution is necessary for the containment of spread of COVID-19 in the State.

Now, therefore after considering the current situation of the COVID-19 pandemic and the overall circumstances, in exercise of the powers conferred under the Section 24 (e) of the DM Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby orders that the existing orders of SEC dated 26.03.2021 for management of COVID-19 will be strictly enforced subject to following modification:

- I. All educational institutions schools/colleges/universities/institutions will remain closed upto 15.04.2021. All teaching/non-teaching staff will however continue to attend their respective institutions. Students of the classes having their scheduled examinations in the near future can visit the school/educational institute to clear any doubts with a written consent of the parents/guardian. All coaching centres to prepare for competitive exams and nursing/medical/dental colleges will remain open and ensure observance of the COVID-19 SOPs issued by Government from time to time. Schools/Institutions having residential facilities need not close their hostel facilities but must observe SOPs issued by Ministry of Health & Family Welfare, Government of India for Covid-19 prevention and COVID-19 appropriate behaviour. The educational institutions that are earmarked as examination centres shall be properly sanitized prior to being used as examination centers. All such schools/educational institutions also must appoint a compliance officer for this purpose.

All the Departments and Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the SEC and various SOPs *ibid*.

This Order shall remain in force, in all parts of the State with immediate effect till further orders.



**ORDER**

Whereas an Order dated 25.03.2021 was issued to arrest the spread of COVID-19 in the State for compliance with order and guidelines issued by the Ministry of Home Affairs, Government of India for containment of COVID-19 dated 23.03.2021.

And whereas, after a careful review of the emerging situation regarding spread of COVID-19 epidemic in the State it is apparent that it still remains a public health risk and caution is necessary for the containment of spread of COVID-19 in the State.

Now, therefore after considering the emerging situation of the COVID-19 pandemic and the overall circumstances resulting from non-adherence to COVID-19 safety protocols by public, in exercise of the powers conferred under the Section 24 (e) of the DM Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby orders that the existing orders of SEC for management of COVID-19 will be strictly enforced subject to following directions:

- I. All educational institutions schools/colleges/universities/institutes will remain closed upto 04.04.2021, except for the classes having their scheduled examinations, as a precautionary measure. All teaching/non-teaching staff will however continue to attend their respective institutions. All coaching centres and nursing/medical/dental colleges will remain open and ensure observance of the COVID-19 SOPs issued by respective departments. Schools/Institutions having residential facilities need not close down their hostel facilities but must observe SOPs issued by Ministry of Health & Family Welfare, Government of India for COVID-19 appropriate behaviour. All such schools/ educational institutions must appoint a compliance officer for this purpose.
- II. All kind of Holi celebrations in public places are strictly prohibited in the State. However, family celebrations inside the residential dwellings shall be permitted.
- III. All congregations and *langars* inside & around the temples/ places of worship are prohibited with immediate effect. However, pilgrims/devotees may be allowed to enter the sanctum sanatorium for offering *puja/darshan* etc. With due adherence to the SOPs issued by the respective departments.
- IV. All the offices of Government Departments/ PSUs/ Autonomous Bodies including the H.P. Secretariat will remain closed on 03.04.2021 to break the chain of transmission.



- V. District Administration will take decision on imposing further restrictions/conditions keeping in view the rate of positivity, fatality rate and number of positive cases etc. in their respective districts or local areas.

All the Departments and Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the SEC and various SOPs *ibid*.

**Penal Provisions:**

Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable. Extract of these penal provisions is at Annexure II of MHA order.

This Order shall remain in force, in all parts of the State with immediate effect till further orders.



**ORDER**

Whereas an Order dated 26.02.2021 was issued to arrest the spread of COVID-19 in the State for a period upto 31.03.2021 with guidelines issued by the Ministry of Home Affairs, Government of India for Surveillance, Containment and Caution dated 26.02.2021. A subsequent order with specific directions by SEC dated 21<sup>st</sup> March 2021 was issued after considering the emerging situation of the COVID-19 pandemic and the overall circumstances resulting from non-adherence to COVID-19 safety protocols by public.

Whereas, on the directions of National Disaster Management Authority (NDMA) under section 6(2)(i) of the Disaster Management Act, 2005 and in exercise of the powers, conferred under Section 10(2)(l) of the Disaster Management Act, 2005, the Chairperson National Executive Committee (NEC) has issued an Order No. 40-3/2020-DM-I(A) dated 23.03.2021 with guidelines for containment of COVID-19 in the country.

Now, therefore after considering the prevalent status of the COVID-19 pandemic and the overall circumstances, in exercise of the powers conferred under the Section 24 (e) of the DM Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby orders the implementation of the directions and guidelines contained in the Order of NEC dated 23.03.2021 (Annexure A) in addition to the SEC Order dated 21.03.2021 (Annexure B) till further orders.

It is of utmost importance to follow test-track-treat protocol in all parts of the State as per the Guidelines of MHA. The protocol includes aggressive testing to detect early COVID-19 positive cases, timely isolation of such positive cases by providing them clinical interventions, timely contact tracing as per protocol and demarcation of Containment Zones.

 All the Departments and Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the NEC and SOPs ibid.

## **Guidelines for effective control of COVID-19**

**[As per Ministry of Home Affairs (MHA) Order No. 40-3/2020-DM-I (A)  
dated 23<sup>rd</sup> March, 2021]**

The coordinated effort of Central and State/UT agencies has resulted in a sustained decline in the number of active COVID-19 cases in the country, continuously for about 5 months. A fresh surge in COVID-19 cases, in some parts of the country, however, is a cause of concern. At this juncture, the substantial gains achieved against the spread of COVID-19 need to be consolidated, and the chain of transmission of the pandemic effectively broken, with a view to expeditiously restore complete normalcy.

With the last guidelines issued by Ministry of Home Affairs (MHA) on 27.1.2021, all economic and other activities have been opened up in a phased manner, with the stipulation that the prescribed Standard Operating Procedures (SOPs) be scrupulously followed. In order to ensure that the resumption of activities is successful, it is imperative to strictly enforce the **Test- Track-Treat** protocol in all parts of the country; ensure that COVID appropriate behaviour is scrupulously observed by everyone; and, the ongoing vaccination drive – the largest in the world – is scaled up rapidly, to cover all the target groups.

The following guidelines are issued to be effective from *1<sup>st</sup> April, 2021*.

### **Effective enforcement of the Test-Track-Treat protocol**

#### Test

1. With sustained effort, the capacity of total daily tests that can be conducted across the country has gone up substantially. There is need to ensure that the tests being conducted are uniformly distributed across all districts, with adequate testing to be done in districts reporting higher number of cases. The proportion of RT-PCR tests in the total mix should be scaled up, on best effort basis, to 70% or more. States and UTs, where the proportion of RT-PCR tests is less, should rapidly increase testing through this protocol, to reach the prescribed level.

#### Track

2. The new positive cases detected as a result of intensive testing need to be isolated/ quarantined at the earliest; and, their contacts have to be traced at the earliest, and similarly isolated/ quarantined. Containment Zones, accordingly, have to be demarcated, and prescribed containment measures implemented within such Zones.
3. Effective demarcation of Containment Zones, in vulnerable and high incidence areas, is key to breaking the chain of transmission and controlling the spread of the virus. Containment Zones shall be carefully demarcated by the district authorities, at the micro level, taking into consideration the guidelines prescribed by the Ministry of Health and Family Welfare

(MoHFW) in this regard. The list of Containment Zones will be notified on the websites by the respective District Collectors and by the States/ UTs. This list will also be shared with MoHFW on a regular basis.

4. Within the demarcated Containment Zones, containment measures, as prescribed by MoHFW, shall be scrupulously followed, as under:
  - i. Only essential activities shall be allowed in the Containment Zones.
  - ii. There shall be strict perimeter control to ensure that there is no movement of people in or out of these zones, except for medical emergencies and for maintaining supply of essential goods and services.
  - iii. There shall be intensive house-to-house surveillance by surveillance teams formed for the purpose.
  - iv. Testing shall be carried out as per prescribed protocol.
  - v. Listing of contacts shall be carried out in respect of all persons found positive, along with their tracking, identification, quarantine and follow up of contacts for 14 days (80% of contacts to be traced in 72 hours).
  - vi. Surveillance for ILI/ SARI cases shall be carried out in health facilities or outreach mobile units or through fever clinics in buffer zones.
  - vii. **It shall be the responsibility of local district, police and municipal authorities to ensure that the prescribed Containment measures are strictly followed. State/ UT Governments shall ensure accountability of the officers concerned in this regard.**

#### Treat

5. Quick isolation of COVID-19 patients shall be ensured in treatment facilities/ home (subject to fulfilling the home isolation guidelines).
6. Clinical interventions, as prescribed, shall be administered. Capacity building of health workers and professionals shall be an ongoing exercise, to be conducted at all levels, with a view to ensure that the prescribed clinical management protocol is understood clearly and administered accordingly.
7. The concerned agencies – of the Central and State/ UT Governments – shall ensure adequate availability of COVID dedicated health and logistics (including ambulatory) infrastructure, based on their assessment of the case trajectory.
8. Effective infection prevention and control practices shall be followed in treatment facilities and by health care workers and professionals.

## **COVID appropriate behavior**

9. State/ UT Governments shall take all necessary measures to promote COVID-19 appropriate behaviour. Strict enforcement of wearing of face masks, hand hygiene and social distancing must be ensured.
10. Wearing of face masks is an essential preventive measure. In order to enforce this core requirement, States and UTs may consider administrative actions, including imposition of appropriate fines, on persons not wearing face masks in public and work spaces.
11. Observance of social distancing in crowded places, especially in markets, weekly bazaars and public transport, is also critical for containing the spread of the infection. SOP issued by Ministry of Health and Family Welfare (MoHFW) to regulate crowds in market places, shall be strictly enforced by States and UTs.
12. SOPs for regulating travel in aircrafts, trains and metro rails are already in place, which shall be strictly enforced. States and UTs shall issue necessary guidelines for regulating travel in other modes of public transport, e.g., buses, boats etc., and ensure that these are strictly complied with.
13. The National Directives for COVID-19 Management, as specified in **Annexure I**, shall be strictly followed throughout the country.

## **Strict adherence to the prescribed SOPs**

14. All activities have been permitted outside Containment Zones and SOPs have been prescribed for various activities. These include: movement by passenger trains; air travel; metro trains; schools; higher educational institutions; hotels and restaurants; shopping malls, multiplexes and entertainment parks; yoga centres and gymnasiums; exhibitions, assemblies and congregations, etc.
15. The SOPs, as updated from time to time, shall be strictly enforced by the authorities concerned, who shall be responsible for their strict observance.

## **Vaccination**

16. Government of India has launched the world's largest vaccination drive against COVID-19. The National Expert Group on Vaccine Administration for COVID-19 (NEGVAC) provides guidance on prioritization of population groups, procurement & inventory management, and vaccine selection delivery and tracking. The recommendations of NEGVAC are considered and finalized by the Central Government.
17. While the vaccination drive is proceeding smoothly, the pace is uneven across different States and UTs; and, the slow pace of vaccination in some States/ UTs is a matter of concern. Vaccination against COVID-19, in the present scenario, is critical to break the chain of transmission. Therefore, all State/ UT Governments should rapidly step up the pace of vaccination,



to cover all priority groups, as recommended by NEGVAC and approved by the Central Government, urgently and in an expeditious manner.

#### **Local restrictions**

18. States and UTs, based on their assessment of the situation, may impose local restrictions at district/ sub-district and city/ ward level, with a view to contain the spread of COVID-19.
19. There shall be no restriction on inter-State and intra-State movement of persons and goods including those for cross land-border trade under Treaties with neighbouring countries. No separate permission/ approval/ e-permit will be required for such movements.

#### **Protection of vulnerable persons**

20. Persons above 65 years of age, persons with co-morbidities, pregnant women, and children below the age of 10 years are advised to take necessary precautions.

#### **Use of *Aarogya Setu***

21. Use of *Aarogya Setu* may continue on best effort basis on compatible mobile phones. This will facilitate timely provision of medical attention to those individuals who are at risk.

#### **Strict enforcement of the guidelines**

22. All the District Magistrates shall strictly enforce the above measures. For the enforcement of social distancing, State/ UT Governments may, as far as possible, use the provisions of Section 144 of the Criminal Procedure Code (CrPC) of 1973.
23. Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable. Extracts of these penal provisions are at **Annexure II**.

**NATIONAL DIRECTIVES FOR COVID-19 MANAGEMENT**

1. **Face coverings:** Wearing of face cover is compulsory in public places; in workplaces; and during transport.
2. **Social distancing:** Individuals must maintain a minimum distance of 6 feet (2 gaz ki doori) in public places.  
Shops will ensure physical distancing among customers.
3. **Spitting in public places** will be punishable with fine, as may be prescribed by the State/ UT local authority in accordance with its laws, rules or regulations.

*Additional directives for Work Places*

4. **Work from home (WfH):** As far as possible the practice of WfH should be followed.
5. **Staggering of work/ business hours** will be followed in offices, work places, shops, markets and industrial & commercial establishments.
6. **Screening & hygiene:** Provision for thermal scanning, hand wash or sanitizer will be made at all entry points and of hand wash or sanitizer at exit points and common areas.
7. **Frequent sanitization** of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., will be ensured, including between shifts.
8. **Social distancing:** All persons in charge of work places will ensure adequate distance between workers and other staff.

**Offences and Penalties for Violation of Lockdown Measures**

**A. Section 51 to 60 of the Disaster Management Act, 2005**

**51. Punishment for obstruction, etc.**—Whoever, without reasonable cause —

- (a) obstructs any officer or employee of the Central Government or the State Government, or a person authorised by the National Authority or State Authority or District Authority in the discharge of his functions under this Act; or
- (b) refuses to comply with any direction given by or on behalf of the Central Government or the State Government or the National Executive Committee or the State Executive Committee or the District Authority under this Act,

shall on conviction be punishable with imprisonment for a term which may extend to one year or with fine, or with both, and if such obstruction or refusal to comply with directions results in loss of lives or imminent danger thereof, shall on conviction be punishable with imprisonment for a term which may extend to two years.

**52. Punishment for false claim.**—Whoever knowingly makes a claim which he knows or has reason to believe to be false for obtaining any relief, assistance, repair, reconstruction or other benefits consequent to disaster from any officer of the Central Government, the State Government, the National Authority, the State Authority or the District Authority, shall, on conviction be punishable with imprisonment for a term which may extend to two years, and also with fine.

**53. Punishment for misappropriation of money or materials, etc.**—Whoever, being entrusted with any money or materials, or otherwise being, in custody of, or dominion over, any money or goods, meant for providing relief in any threatening disaster situation or disaster, misappropriates or appropriates for his own use or disposes of such money or materials or any part thereof or wilfully compels any other person so to do, shall on conviction be punishable with imprisonment for a term which may extend to two years, and also with fine.

**54. Punishment for false warning.**—Whoever makes or circulates a false alarm or warning as to disaster or its severity or magnitude, leading to panic, shall on conviction, be punishable with imprisonment which may extend to one year or with fine.

**55. Offences by Departments of the Government.**—(1) Where an offence under this Act has been committed by any Department of the Government, the head of the Department shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly unless he proves that the offence was committed without his



knowledge or that he exercised all due diligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where an offence under this Act has been committed by a Department of the Government and it is proved that the offence has been committed with the consent or connivance of, or is attributable to any neglect on the part of, any officer, other than the head of the Department, such officer shall be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

**56. Failure of officer in duty or his connivance at the contravention of the provisions of this Act.**—Any officer, on whom any duty has been imposed by or under this Act and who ceases or refuses to perform or withdraws himself from the duties of his office shall, unless he has obtained the express written permission of his official superior or has other lawful excuse for so doing, be punishable with imprisonment for a term which may extend to one year or with fine.

**57. Penalty for contravention of any order regarding requisitioning.**—If any person contravenes any order made under section 65, he shall be punishable with imprisonment for a term which may extend to one year or with fine or with both.

**58. Offence by companies.**—(1) Where an offence under this Act has been committed by a company or body corporate, every person who at the time the offence was committed, was in charge of, and was responsible to, the company, for the conduct of the business of the company, as well as the company, shall be deemed to be guilty of the contravention and shall be liable to be proceeded against and punished accordingly:

Provided that nothing in this sub-section shall render any such person liable to any punishment provided in this Act, if he proves that the offence was committed without his knowledge or that he exercised due diligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where an offence under this Act has been committed by a company, and it is proved that the offence was committed with the consent or connivance of or is attributable to any neglect on the part of any director, manager, secretary or other officer of the company, such director, manager, secretary or other officer shall also, be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

*Explanation.*—For the purpose of this section—

- (a) “company” means anybody corporate and includes a firm or other association of individuals; and
- (b) “director”, in relation to a firm, means a partner in the firm.



**59. Previous sanction for prosecution.**—No prosecution for offences punishable under sections 55 and 56 shall be instituted except with the previous sanction of the Central Government or the State Government, as the case may be, or of any officer authorised in this behalf, by general or special order, by such Government.

**60. Cognizance of offences.**—No court shall take cognizance of an offence under this Act except on a complaint made by—

- (a) the National Authority, the State Authority, the Central Government, the State Government, the District Authority or any other authority or officer authorised in this behalf by that Authority or Government, as the case may be; or
- (b) any person who has given notice of not less than thirty days in the manner prescribed, of the alleged offence and his intention to make a complaint to the National Authority, the State Authority, the Central Government, the State Government, the District Authority or any other authority or officer authorised as aforesaid.

## **B. Section 188 in the Indian Penal Code, 1860**

**188.** Disobedience to order duly promulgated by public servant.—Whoever, knowing that, by an order promulgated by a public servant lawfully empowered to promulgate such order, he is directed to abstain from a certain act, or to take certain order with certain property in his possession or under his management, disobeys such direction, shall, if such disobedience causes or tends to cause obstruction, annoyance or injury, or risk of obstruction, annoyance or injury, to any person lawfully employed, be punished with simple imprisonment for a term which may extend to one month or with fine which may extend to two hundred rupees, or with both; and if such disobedience causes or trends to cause danger to human life, health or safety, or causes or tends to cause a riot or affray, shall be punished with imprisonment of either description for a term which may extend to six months, or with fine which may extend to one thousand rupees, or with both.

*Explanation.*—It is not necessary that the offender should intend to produce harm, or contemplate his disobedience as likely to produce harm. It is sufficient that he knows of the order which he disobeys, and that his disobedience produces, or is likely to produce, harm.

### *Illustration*

An order is promulgated by a public servant lawfully empowered to promulgate such order, directing that a religious procession shall not pass down a certain street. A knowingly disobeys the order, and thereby causes danger of riot. A has committed the offence defined in this section.

Dear Chief Secretary,

Kindly refer to Ministry of Home Affairs (MHA) Order of even number issued today vide which guidelines for effective control of COVID-19 have been issued, which will be effective till 30<sup>th</sup> April, 2021.

2. As you are aware, with the coordinated efforts of the Central and State agencies, substantial gains have been achieved in containing the spread of COVID-19, which were visible in the sustained decline in the number of active cases, continuously for about 5 months. However, a fresh surge in COVID-19 cases is being witnessed in some parts of the country. Further, the situation might aggravate in view of the upcoming festivals.
3. It has been observed that there is a general laxity in the observance of COVID-19 appropriate behaviour. In this regard, my D.O. letter No. 40-34/2020-DM-I(A) dated 19.03.2021 may also be referred. It is again reiterated that State/UTs should take all necessary measures to promote COVID-19 Appropriate behaviour in work places and in public, especially in crowded places. For strict enforcement of wearing of masks, hand hygiene and social distancing, States/UTs may consider administrative actions, including imposition of appropriate fine.
4. It has further been observed that guidelines issued by Ministry of Health and Family Welfare (MoHFW) on containment measures are not being strictly followed. It is again re-iterated that Containment Zones have to be carefully demarcated by district authorities, at micro level, and containment measures shall be strictly enforced by the authorities concerned, taking into consideration guidelines prescribed by MoHFW.
5. It is of utmost importance to follow test-track-treat protocol in all parts of the country. The protocol includes aggressive testing to detect early COVID-19 positive cases, timely isolation of such positive cases by providing them clinical interventions, timely contact tracing as per protocol and demarcation of Containment Zones. In some States/UTs, the proportion of RT-PCR test in the total mix is low. Such States/UTs should rapidly increase the proportion of RT-PCR test to the prescribed level of 70% or more.

6. As emphasized earlier, guidelines/SOPs issued for various activities shall be strictly followed. States/UTs, based on their assessment of the situation, may impose local restrictions at district/sub-district and cities/ward level, with a view to contain the spread of COVID-19. However, there shall be no restriction on inter-State and intra-State movement of persons and goods including those for cross land-border trade under treaties with neighbouring countries.

7. The world's largest vaccination drive, against COVID-19, is proceeding smoothly in the country. However, the pace is uneven across different States and UTs, which is a matter of concern. Vaccination against COVID-19, in the present scenario, is critical to break the chain of transmission. Therefore, all State/UT Governments should rapidly step up the pace of vaccination, to cover all priority groups in an expeditious manner.

8. I would urge you to ensure compliance of the aforesaid guidelines and direct all authorities concerned for its strict implementation. Further, guidelines issued by MHA and consequent Orders issued by the respective State Governments/UT Administrations should be widely disseminated to the public and to the field functionaries for implementation.

**ORDER**

Whereas an Order dated 26.02.2021 was issued to arrest the spread of COVID-19 in the State for a period upto 31.03.2021 with guidelines issued by the Ministry of Home Affairs, Government of India for Surveillance, Containment and Caution.

And whereas, after a careful review of the emerging situation regarding spread of COVID-19 epidemic in the State it is apparent that it still remains a public health risk and caution is necessary for the containment of spread of COVID-19 in the State.

Now, therefore after considering the emerging situation of the COVID-19 pandemic and the overall circumstances resulting from non-adherence to COVID-19 safety protocols by public, in exercise of the powers conferred under the Section 24 (e) of the DM Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby orders that the existing orders of SEC for management of COVID-19 will be strictly enforced subject to following directions:

- i. The State will observe NO MASK – NO SERVICE policy with immediate effect. People with face cover/mask will only be allowed to board public/private transport such as train, buses and taxis etc and to enter hospitals, temples, langar halls, schools, colleges, Govt offices or private establishments/shops etc for availing any services/goods.
- ii. All ongoing melas in the State shall be wound up at the earliest not later than 23.03.2021 and no new Melas will be organised in the State after 23rd March 2021.
- iii. All social/ religious/ political/ cultural and other gatherings will be organized with the prior permission of the district administration after 25/3/2021. Local Administration shall keep a close watch on already scheduled gatherings and ensure to implement the SOPs especially in relation to social distancing and face cover/wearing of masks.



- iv. All social/ religious/ sports/ entertainment/ educational/ cultural gatherings are allowed with maximum of 50% of the capacity or 200 whichever is less in closed spaces; and 50% of the size of the open grounds/spaces subject to compliance of all instructions, SOPs/guidelines regarding social distancing and wearing of face covers etc.
- v. The Department of IT/District Administration shall activate the module for granting permission for the gatherings as per the SoPs of the SEC from 25th March 2021 onwards.
- vi. In gatherings where community kitchen or Dhaam/Langars, or professional catering is to be arranged, the managers and catering staff as far as possible, will be required to undergo tests through Rapid Antigen/RT-PCR test kits for COVID-19 with the help of local health officials not earlier than 96 hours before the event. The cooking staff will ensure no cooking without masks, gloves and head cover.
- vii. There will be prohibition on langars in closed premises and cooking by non-tested staff. The organisers will also ensure adherence to highest level of personal and environmental hygiene all the times, especially at the time of preparing, serving /eating meals and disposal of the waste etc.
- viii. The details of permissions granted for gatherings shall also be shared with Panchayati Raj Institutions (PRIs) and Urban Local Bodies (ULBs) apart from the officer incharges of police stations in the State.
- ix. All the office bearers of the PRIs/ULBs as the case may be, are to ensure that all the SOPs including wearing of mask, social distancing, home isolation, public gathering etc. issued by the State Government are strictly adhered to. They will visit and coordinate with the event organizers prior to the event that only the permitted number of the persons should attend the event with strict compliance of COVID-19 directives. Any violations of the directives in this regard shall be brought to the notice of the District Administration forthwith.
- x. Local Administration while granting permissions to the organizers, may impose additional conditions, as may deem fit, to contain the spread of COVID-19.

**Penal Provisions:**

Any person violating these directions and COVID-19 safety measures will be liable to be proceeded against as per the provisions of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.
